

CLACKAMAS COUNTY **ENERGY EFFICIENCY ON MAIN STRI Rebate Application**

Clackamas County is offering rebates for eligible energy efficiency upgrades. The rebates pay:

\$.10/kWh saved over five years* (\$.50/annual kWh saved) for electric customers, or

\$1.15/therm saved over five years* (\$5.75/annual therm saved) for gas customers

- * Rebates for HVAC projects will be paid based on 20 years of savings at these same rates.
- Rebates are not to exceed \$2,500.

• Clackamas County EEMS rebates are in addition to ETO incentives, and the sum of all financial incentives cannot exceed the total project cost.
